1. Quotations are invited for printing of 2019 issue of English Journal (Journal of Constitutional and Parliamentary Studies) and 2017 issue of Hindi Journal (Loktantra Samiksha) as per following requirements/ specifications:

i)	No. of copies	200 hardcopies each of both English and Hindi journals e-copies of the journals (as per requirements)
ii)	No. of Pages	Approx. 100 for English Journal Approx. 80 for Hindi Journal
iii)	Journal Size	6.25 inches * 9.5 inches
iv)	Cover pages	Art Card, 350 grm, Four colour, Laminated
v)	Text page	Natural shade, Maplitho paper 70gm, Black & White
vi)	Reprints	10 copies of each articles

2. Rates quoted for printing of journals should also include rates for (i) formatting/ page-setting and (ii) proof reading.
3. Rates for printing of the two journals should be indicated separately.
4. Rates for providing password protected single user accessible e-copies (exact number thereof to be determined subsequently) of the journals should also be indicated separately.
5. Changes in cost of printing, if any, due to increase/ decrease in number of pages of the journals may also be indicated in the quotations.
6. Quotations should also indicate the time period required for printing of the journal after placing the 'Print Order'.
7. Quotations in sealed cover and addressed to the Director of the Institute should reach us **latest by 02:00 pm on 17th March 2020 (Tuesday)**.
8. The bidders are also required to sign the 'Declaration' given at the next page and to enclose it with the quotation.
9. Manuscripts are available in MS-Word files.
10. Quotations (i) not in sealed covers, (ii) received after the said time and date, (iii) not accompanying signed copy of the Declaration, and (iv) not as per specifications, will not be entertained.
11. The date for opening the Quotations, which will be found in order, will be intimated separately.
12. Institute reserves the right to cancel any or all the quotations without assigning any reason.
